



## 2023 – 2026 Downtown Georgetown BIA Board of Directors Nomination Form

The DGBIA Board consists of minimum 6, maximum 10 Directors plus one appointed Member of Council. A slate of Board members is elected for a term of four years in alignment with the Municipal Act and Municipal Elections. Board members elected after the BIA Board general elections will only serve the remainder of the four-year term. Board meetings are held minimum 10 times annually.

- f. A document issued or certified by a court in Ontario
- g. Any other document from the government of Canada, Ontario or a municipality in Ontario or from an agency or such a government i.e. Incorporation Document or HST Number
- h. A property tax assessment
- i. A credit card statement, bank account statement
- j. A Workplace Safety and Insurance Board Statement
- k. A utility bill for hydro, water, gas, telephone or cable TV or a bill from a public utilities commission
