- This category is for farmers that are suitable for the market & in line with market values and guidelines.
- Farmers must adhere to all applicable provincial and federal regulations regarding labeling of products for sale at Farmers Markets.
- New applicants will be assigned to the Church Street Lot unless otherwise notified.
- Applicants are accepted on a trial basis for the season and at the discretion of the Market Manager.
- Spaces are assigned based on availability and Market needs. Applicants are reviewed by the Farmers Market Manager and will be accepted or denied based on our policies and criteria for suitability with a Producer-based Farmers' Market. All decisions are final.
- Refunds will be issued **ONLY** in the following instances:
 - Inclement weather forces the market to shut down. Refunds will be issued only to **non-seasonal prepaid** vendors.
 - Regional or province-wide restrictions prevent certain types of vendors from selling at the market. Refunds will be issued only to the affected vendors.

 vendor status, and no refund will be issued.**
